## COVID-19 Waiver and Release

### Explanation of the Risk Related to Coronavirus/COVID-19

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and is believed to spread mainly from person-to-person contact. As a result, federal, state, and local governments and health agencies recommend social distancing and have, in many locations, prohibited the congregation of groups of people.

Bair Lake Bible Camp (BLBC) has put in place preventative measures to reduce the spread of COVID-19; however, BLBC cannot guarantee that you or your child(ren) will not become infected with COVID-19. Further, attending BLBC could increase your risk and your child(ren)'s risk, as well as the risk of others you live with, of contracting COVID-19.

### Assumption of Risk, Waiver, Release, and Indemnity Agreement

By signing this agreement, I acknowledge the contagious nature of COVID-19 and voluntarily assume the risk that my child(ren), the other people we live with, and I may be exposed to or infected by COVID-19 by attending BLBC and that such exposure or infection may result in personal injury, illness, permanent disability, and/or death. I understand the risk of becoming exposed to or infected by COVID-19 at BLBC may result from the actions, omissions, or negligence of myself and others, including, but not limited to, BLBC employees, volunteers, and program participants, and their families.

I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to my child(ren), including those who attend and those who do not attend BLBC, or myself (hereinafter "my family"), including, but not limited to, the risk of personal illness, injury, disability, death, illness, damage, loss, claim, liability, or expense, of any kind, that my family may experience or incur in connection with my child(ren)'s attendance at BLBC or participation in BLBC programming ("Claims"). On my own behalf, and on behalf of my participating child and the remainder of my family members whom I have legal authority, I hereby release, covenant not to sue, discharge, and hold harmless BLBC, its directors, officers, employees, agents, contractors (including their sub-contractors and respective agents), volunteers, successors, and assigns (hereinafter "the BLBC Team," of and from the Claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto. I understand and agree that this release includes any Claims based on the actions, omissions, or negligence of the BLBC Team, whether a COVID-19 infection occurs before, during, or after participation in any BLBC program.

I agree to indemnify and hold harmless (in other words, to reimburse and to be responsible for instead of) the BLBC Team from all claims for any liability, injury, loss, damage, or expense, including attorneys' fees (including the cost of defending any Claim I might make, or that might be made on my behalf, that is released or waived by my execution of this Agreement), in any way connected with or arising from my child(ren)'s attendance at BLBC or participation in BLBC program. This obligation will survive the termination of this Agreement.
